

**Subject :** Fund for running SSP centers during 2013-2014.

The undersigned is directed, by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs. 6,98,05,800/- (Rupees Six crore ninety eight lakh five thousand eight hundred) only for payment of the existing honorarium of Siksha Sahayikas and Academic Supervisors as per G.O. No.: 115/MA/C-10/3S-33/2010 dated 18.02.2011; for the period from April 2013 to July 2013 to the Director of Local Bodies, West Bengal for smooth running of Sishu Shiksha Kendras within the Urban Local Bodies during 2013-2014.

2. The amount sanctioned in Para-I above amounting to Rs. 6,98,05,800/- is to be monitored and sub-allotted from the level of Director of Local Bodies, West Bengal in favour of the Urban Local Bodies in the prescribed format of Finance Department (vide G.O. No. 2552-F(Y) dt. 27.03.2012) and the District Magistrate of the concerned districts will act as the D.D.O. for drawal by transfer credit to the L.F. Account of respective Urban Local Bodies. For the municipalities where Administrators have been appointed under sub-section (4) of section 14 of the West Bengal Municipal Act, 1993 as per this department order no. 315/MA/O/C-4/1M-1/2001 dated 11<sup>th</sup> July, 2013, fund will be released to the concerned ULBs with instruction to the concerned Administrators.
3. The charge is debitible to the Head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj Institutions-00-200-Other Miscellaneous Compensation & Assignments-NP-Non-Plan-034-Fixed Grants to Municipal Corporations and other Urban Local Bodies[MA]-V-31-Grants-in-aid-GENERAL-02-Other Grants" under Demand No. 39/MA in the current year's i.e. 2013-14 vote-on-account Budget Provision.
4. The Utilisation Certificates is to be furnished by the Director of Local Bodies, West Bengal in terms of Note-2 below S.R. 330A of the Treasury Rules, West Bengal, Volume-I, after collecting the Utilisation Certificate from the ULBs through D.M/S.D.O; directly to the Principal Accountant General (A&E), West Bengal with a copy to this Department.
5. This order issues in exercise of the powers delegated under Finance Department Memo No. 03-FB dated 1.04.2013.
6. The Principal Accountant General (A&E), West Bengal and all other concerned are being informed.


