ORDER

AND WHEREAS, the Online applications for (1) NOC for non-residential use of the residential land and (2) transfer of the leasehold right of the residential land in respect of residential leasehold land of Bidhannagar (Salt Lake Township) and residential /commercial leasehold lands of Kalyani Township have already been created and developed by this Department with the technical assistance of Webel Technology Limited;

However, the Offline applications of the above noted two services received by the Office of the Land Manager, Bidhannagar / Estate Manager, Kalyani before the scheduled date (i.e., 25th July, 2022) may be processed in Offline mode;

THIS ORDER is being issued for the interest of public and top most priority should be attached to this and all necessary actions including adequate publicity and awareness creation among the stakeholders shall be arranged from the ends of Land Manager, Bidhnnagar/Estate Manager, Kalyani and also from the ends of Bidhannagar Municipal Corporartion and Kalyani Municipality.
