WHEREAS in compliance of the order of the Hon'ble High Court, Calcutta dated 21.09.2012 in W.P. No.19340(W) of 2008 (Sufia Khatoon -Vs- State of West Bengal), Grievance Committees are to be constituted at the level of Municipal Corporations, Municipalities and Block Levels consisting of Panchayats for effective implementation of rules, regulations and guidelines pertaining to erection and installation of mobile towers by mobile phone service providers.

AND WHEREAS each Grievance Committee shall consist of two members, one of them shall be Chief Executive Officer of the Municipal Corporation / Chief Executive Officer of the Municipality / Block Development Officer at the block level consisting of all Panchayats within its jurisdiction and the other member shall be the Law Officer of the West Bengal Pollution Control Board.

AND WHEREAS the Grievance Committees shall have jurisdiction over the respective areas and all complaints in respect of illegal and unauthorized erection and installation of Mobile Towers and Mobile Tower installed in breach of the rules, regulations and guidelines framed by the West Bengal Pollution Control Board shall be entertained by Grievance Committees. It shall examine the complaints after giving an opportunity of being heard to all concerned and take appropriate decision in the matter and implement the orders within their jurisdiction.

AND WHEREAS the Grievance Committees shall function as quasi judicial authority and shall have power to impose cost against persons filing false and frivolous complaints. The Grievance Committees shall take decision in respect of issues and contentions raised in the petition within a reasonable time preferably within three months of the matter being referred to it or a complaint being lodged.

AND WHEREAS the Grievance Committees shall take assistance of the administrative machinery of the local authority and the officer- in- charge of the respective police stations for effective implementation of the orders where offending mobile tower is proposed to be installed or is already installed.

AND WHEREAS the High Court, Calcutta shall not entertain any public interest litigation pertaining to the subject matter of irregularities and illegalities in erection and installation of mobile towers and /or breach / violation of the guidelines issued by the West Bengal Pollution Control Board unless the matter is first referred to by way of complaint to the Grievance Committees.

NOW THEREFORE, the Governor is hereby pleased to constitute Grievance Committees to look after the issues related to mobile tower at the Corporation Level/ Municipal Level / Block Level in the State of West Bengal.
