Sub: Payment of Grants on account of O & M of Municipal Water Supply schemes for the year 2012-2013 during 2013-2014.

The undersigned is directed, by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs. 1,98,85,000/- (Rupees One crore ninety eight lakhs eighty five thousand) only to the Urban Local Bodies as per enclosed statement for payment of cost towards Operation & Maintenance of Municipal Water supply scheme to each Urban Local Body on ad-hoc basis for the year 2012-2013 during 2013-2014.

2. The District Magistrate is hereby authorised to draw the grants sanctioned above and disburse the same to the Urban Local Bodies under the jurisdiction by transfer credit.
3. The charge is debitable to the head of account "2215-Water Supply & Sanitation-01-Water Supply-101-Urban Water Supply-NP-Non-plan-005-O&M of Municipal Water Supply Scheme-19-Maintenance-V" under Demand No. 39/MA in the current Year's vote-on-account Budget i.e. 2013-14
4. The Utilisation Certificate is to be furnished by the Urban Local Bodies in terms of Note-2 below S.R. 330A of West Bengal Treasury Rules, Volume-I directly to the Principal Accountant General (A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilised.
5. This order issues in exercise of the power delegated under Finance Department's memo no. 03 – FB dated 01.04.2013.
6. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
