ORDER

With reference to Finance Department's Memorandum No.267-F(Pen), dated 21.07.2014 the Governor is pleased to decide that all the pensioners of Municipal Corporations, Municipalities, Notified Area Authorities of this State including the holders of provisional pension who retired prior to 30.09.2013 and also the pensioners who retired or died after 30.09.2013 but prior to 01.09.2014 and whose basic pension plus relief on pension as on 31st March,2014 **did not exceed Rs.22,000/- (Rupees twenty two thousand)** only and are not eligible to receive Ad-hoc Bonus shall be paid an **Ex-gratia grant of Rs.1,500/- (Rupees One thousand five hundred)** only in lump per head in this year.

2. The **Ex-gratia** grant sanctioned herein will also be admissible to the holders of family pension, ex-gratia family pension and Ad-hoc family pension.
3. The Municipal Corporations, Municipalities, Notified Area Authorities shall meet the expenses on this account out of their own funds.
4. The payment of **Ex-gratia** as sanctioned hereinabove should be made by **23rd July, 2014 for Muslim Municipal Pensioners/Family Pensioners and other than Muslim Municipal Pensioners/Family Pensioners** the benefits should be disbursed in between **15th September, 2014 to 22nd September, 2014.**
