
Sir/ Madam,

I am directed to forward herewith the Gazette publication of the notification No. 981/MA/O/C-4/1A-23/2017 dtd. 31/12/2018 enforcing the West Bengal Municipal Service Commission Act, 2018 with effect from 2<sup>nd</sup> January, 2019 and also Gazette publication of Notification No. 02/MA/O/C-4/1A-23/2017 dtd. 02/01/2019 constituting the West Bengal Municipal Service Commission with effect from 2<sup>nd</sup> January, 2019 and to draw your kind attention to the fact that as per provision of the West Bengal Municipal Service Commission Act, the West Bengal Municipal Service Commission is empowered to select personnel of all Urban Local Bodies and Development Authorities as and when required to do so.

In this context, it may be mentioned here that pursuant to publication of the West Bengal Municipal Service Commission Act, 2018, the relevant sections of all four municipal Acts have already been amended empowering the West Bengal Municipal Service Commission to select personnel and the said amendments have already been effected from 2<sup>nd</sup> January, 2019 so that the Commission may start functioning immediately (Copies enclosed).


Therefore you are advised that henceforth all recruitments of personnel shall be made through West Bengal Municipal Service Commission and the Urban Local Bodies and Development Authorities shall send requisition for selection of personnel to the Commission directly as and when required. It is also stated that no fund needs to be transferred to the West Bengal Municipal Service Commission for meeting expenses for selection of personnel.
