ORDER

In order to provide employment in urban areas and to create as well as to maintain civic infrastructure and to add sustainability to the created assets, West Bengal Urban Employment Scheme has been introduced as a State Sponsored Scheme vide this Department's Notification No. 127/MA/P/C-10/3S-17/2010 Pt-I dt. 23.02.2011 where unemployed persons from Urban Local Bodies are engaged directly in various infrastructure development projects taken up under this scheme with daily basis wage of Rs. 100 for direct engagement in work and Rs. 120 for each Supervisor.

- 2. The issue of revision of daily rates of workers and supervisors under West Bengal Urban Employment Scheme was under consideration of the Government for some time past.
- 3. Now in partial modification of para 10.1 of the aforesaid Notification, the Governor has been pleased to allow increase over the present rate of wage with effect from 01.04.2018 raising the daily rate of wages to Rs. 144 for workers and Rs. 172 for Supervisors.
- 4. This order issues with the concurrence of the Finance (Audit) Department vide U.O. No. 344 Group P2 dt. 26.02.2014 and No. Group P2/2017-2018/1161 dt. 15.03.2018.
