Sub: Grant of ex-gratia payment to the Municipal Corporations/Municipalities / N. A. A. Pensioners of this State for the Financial Year 2021-2022.

With reference to Finance Department Memorandum No. 1573-F(P2),dated 18.04.2022, the Governor is pleased to decide that all the pensioners of Municipal Corporations, Municipalities, Notified Area Authorities of this State including the holders of provisional pension who retired prior to 30.09.2021 and also the pensioners who retired or died after 30.09.2021 but prior to 01.09.2022 and whose basic pension plus Dearness relief on pension as on 31st March, 2022 did not exceed Rs. 32,000/- (Rupees Thirty Two Thousand) only and are not eligible to receive Ad-hoc Bonus shall be paid an Ex-gratia grant of Rs. 2700/-(Rupees two thousand seven hundred) only in lump per head in this year.

- The Ex-gratia grant sanctioned herein will also be admissible to the holders of family pension, ex-gratia family pension and Ad-hoc family pension.
- The Municipal Corporations, Municipalities, Notified Area Authorities shall meet the expenses on this account out of their own funds.
- 4. The payment of Ex-gratia as sanctioned herein above should be made before the festival of Id-ul-Fitre of 2022 for the Muslim Municipal Pensioners / Family Pensioners and other than Muslim Municipal Pensioners/Family Pensioners the benefits should be disbursed in between 19.09. 2022 to 23.09. 2022.
