Any loss (if any, as determined by the Court of Law/appropriate Authority) of Public Life including environmental loss due to construction & function of telecom tower & laying optical fibre cables and similar infrastructure projects related to telecom & broad band services to be compensated fully by the telecom companies/ agencies who constructed/ maintaining the telecom tower & laying optical fibre cables and similar infrastructure projects related to telecom & broadband services.
