No. 970-L.—24th July, 2015.—The following Act of the West Bengal Legislature, having been assented to by the Governor, is hereby published for general information:—

West Bengal Act XVI of 2015

THE KOLKATA MUNICIPAL CORPORATION (THIRD AMENDMENT) ACT, 2015.

[Passed by the West Bengal Legislature.]

[Assent of the Governor was first published in the Kolkata Gazettte, Extraordinary, of the 24th July, 2015.]

An Act to amend the Kolkata Municipal Corporation Act, 1980.

WHEREAS it is expedient to amend the Kolkata Municipal Corporation Act, 1980, for the purpose and in the manner hereinafter appearing;

West Ben. Act LIX of 1980.

It is hereby enacted in the Sixty-sixth Year of the Republic of India, by the Legislature of West Bengal, as follows:—

Short title and Commencement.

- 1. (1) This Act may be called the Kolkata Municipal Corporation (Third Amendment) Act, 2015.
- (2) This section shall come into force at once, and the remaining provision of this Act shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.

The Kolkata Municipal Corporation (Third Amendment) Act, 2015.

(Section 2.)

Amendment of section 400 of West Ben. Act LIX of 1980. 2. To sub-section (1) of section 400 of the Kolkata Municipal Corporation Act, 1980, after the third proviso, the following proviso shall be added:—

"Provided also that the Municipal Commissioner may, by order, delegate his powers and functions under the first proviso and the third proviso of this sub-section to the Special Officers, appointed by the Municipal Commissioner with the approval of the State Government on such terms and conditions as may be determined by the Corporation, and expenses for payment of such officers shall be borne on the Municipal Fund.".
