Whereas, the Government in the Department of UD&MA has developed a web portal (<a href="https://ulcudma.gov.in">https://ulcudma.gov.in</a>) for granting of NOC/Clearance of Urban Land Ceiling online by the Competent Authority, Kolkata and the Competent Authority & Sub – Divisional Officer, Alipore of the State under the provisions of Urban Land (Ceiling and Regulation) Act, 1976 as amended from time of time and Rule 4(4) of the Kolkata Municipal Corporation Building Rules, 2009;

And Whereas, the Govt. in the UD&MA Department vide Notification no. 07-UL/O/UDMA-18011(12)/7/2020-IT SEC dated 05.01.2021 had mandated that all ULC Clearances have to be done in online system only, after the system migrated to GO-LIVE on and from 11.01.2021, in the areas under the jurisdiction of the Competent Authority, Kolkata and the Competent Authority & Sub – Divisional officer, Alipore;

Now, in continuation of the aforesaid Notification, it is hereby ordered that Online ULC Clearance system shall "GO LIVE" for areas under the jurisdiction of remaining 10 (ten) Competent Authority & Sub — Divisional Officers of Howrah Sadar , Barrackpore, Barasat Sadar , Kalyani, Serampore, Chandernagore, Hooghly Sadar , Durgapur, Asansol, Uluberia of the State under the provisions of Urban Land (Ceiling and Regulation) Act , 1976 as amended from time of time and in terms of Rule 11(4) of the West Bengal Municipal Building Rules, 2007 w.e.f 01.12.2021, and ULC Clearance/NOC in offline mode shall be discontinued on and from 01.12.2021 for these authorities and all applications are to be disposed in online mode only within the timelines specified in WBRTPS Act, 2013 on and from that date. However, applications received prior to 01.12.2021 may be disposed in offline mode.

This order is issued in the interest of public service and shall take immediate effect.
