NOTIFICATION

No. 570/MA/O/C-4/1M-6/2017, dated Kolkata, the 8th August, 2018 – WHEREAS the Governor expressed his intention vide notification No. 692/MA/O/C-4/1M-6/2017, dated 24th day of October, 2017, published in Kolkata Gazette Extraordinary on 25th day of October, 2017 (hereinafter referred to as the said notification) for inclusion of nine contiguous mouzas of Suri Municipality, constituted under the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) (hereinafter referred to as the said Act), namely - Araipur (part), Tilpara (part) and Karidhya (part) under Tilpara Gram Panchayat, Abdarpur (part) under Mallickpur Gram Panchayat, Brojergram (part) under Karidhya Gram Panchayat and Fatepur (part), Khosnatore (part), Kendua (part) and Hatjanbazar (part) under Kendua Gram Panchayat, which have been constituted under the West Bengal Panchayat Act, 1973 (West Ben. Act XLI of 1973) (hereinafter referred to as the said area) within the jurisdiction of the Suri in the district of Birbhum consisting of the land as described in the Schedule below under clause (c) of section 9 of the said Act;

AND WHEREAS the period of thirty days from the date of publication of the said notification in the *Kolkata Gazette*, for submitting objection in respect to the said notification by any inhabitant of the said areas in writing to the State Government has expired and some objection petitions were received in Urban Development and Municipal Affairs Department, Government of West Bengal from the inhabitants of the said areas during the period aforesaid;

AND WHEREAS the objection petitions were sent to District Magistrate, Birbhum with a request for arrangement to give the petitioners the opportunity of being heard and to send a consolidated report thereof along with his views in this regard to Urban Development and Municipal Affairs Department and after hearing District Magistrate, Birbhum has proposed to include the said areas within the jurisdiction of Suri Municipality in the district of Birbhum consisting of the land as described in the Schedule below;

NOW, THEREFORE, in exercise of the power conferred by clause (c) section 9 of the said Act, the Governor is pleased hereby to include the said areas, consisting of the land as specified in the Schedule below, within the jurisdiction of Suri Municipality in the district of Birbhum: –
