No. 1105-L.—15th September, 2017.—The following Act of the West Bengal Legislature, having been assented to by the Governor, is hereby published for general information:—

West Bengal Act XXXIV of 2017

THE WEST BENGAL MUNICIPAL (SECOND AMENDMENT) ACT, 2017.

[Passed by the West Bengal Legislature.]

[Assent of the Governor was first published in the Kolkata Gazette, Extraordinary, of the 15th September, 2017.]

An Act to amend the West Bengal Municipal Act, 1993.

WHEREAS it is expedient to amend the West Bengal Municipal Act, 1993, for the purposes and in the manner hereinafter appearing;

West Ben. Act XXII of 1993.

It is hereby enacted in the Sixty-eighth Year of the Republic of India, by the Legislature of West Bengal, as follows:—

Short title and Commencement.

- 1. (1) This Act may be called the West Bengal Municipal (Second Amendment) Act, 2017.
- (2) This section shall come into force at once; and the remaining sections shall come into force on such date or dates as the State Government may, by notification in the *Official Gazette*, appoint.

The West Bengal Municipal (Second Amendment) Act, 2017.

(Sections 2-4.)

Amendment of section 2 of the West Ben. Act XXII of 1993. 2. In section 2 of the West Bengal Municipal Act, 1993 (hereinafter referred to as the principal Act), for clause (60A), the following clause shall be substituted:—

'(60A) "State Government" means the Government of the State of West Bengal in the Department of Urban Development and Municipal Affairs; ";

Amendment of section 106.

3. In sub-section (3) of section 106 of the principal Act, for the words "not less than five *per cent*, but not exceeding ten *per cent*,", the words "not exceeding ten *per cent*" shall be substituted.

Amendment of section 340.

- 4. In section 340 of the principal Act,-
 - (i) in clause (f), after the words "public streets", the word ", drain" shall be inserted;
 - (ii) in the "Note—", for the words and numbers "of size less than 8" × 12" and less than 20 microns in thickness", the words "of size and thickness as may be notified by the competent authority" shall be substituted.
