Sub: Grant of ex-gratia payment to the Municipal Corporations /Municipalities/N. A. A. Pensioners of this State.

With reference to Finance Department Memorandum No. 288-F(Pen)/1P-1(16)/11, dated 1st June, 2018 the Governor is pleased to decide that all the pensioners of Municipal Corporations, Municipalities, Notified Area Authorities of this State including the holders of provisional pension who retired prior to 30.09.2017 and also the pensioners who retired or died after 30.09.2017 but prior to 01.09.2018 and whose basic pension plus relief on pension as on 31st March, 2018 did not exceed Rs. 25,000/- (Rupees twenty five thousand) only and are not eligible to receive Ad-hoc Bonus shall be paid an Ex-gratia grant of Rs. 2000/- (Rupees two thousand) only in lump per head in this year.

- The Ex-gratia grant sanctioned herein will also be admissible to the holders of family pension, ex-gratia family pension and Ad-hoc family pension.
- The Municipal Corporations, Municipalities, Notified Area Authorities shall meet the expenses on this account out of their own funds.
- 4. The payment of Ex-gratia as sanctioned hereinabove should be made by 8th June, 2018 for Muslim Municipal Pensioners/Family Pensioners and other than Muslim Municipal Pensioners/Family Pensioners the benefits should be disbursed in between 26th September, 2018 to 5th October, 2018.
