Sub: Online Sanction of Site Plan, Building Plan, e-intimation for commencement, Plinth Level completion, issuance of Occupancy Certificate, sanction of Water and Sewer Line Connection etc., mandatorily w.e.f. 1st March, 2020

Whereas Online Building Plan Sanction (OBPS) is one of the essential Reform milestones for implementation of AMRUT in the State of West Bengal in the notified AMRUT Cities; and

Whereas Online Sanction of Site Plan and Building Plan, e-intimation for commencement of the construction, plinth level completion, issuance of occupancy certificate, sanction of water and sewerage connection etc., are also the essential components of Ease of Doing Business (EoDB); and

Whereas creation of users of those online citizen centric services is the mandatory requirement of securing the rank of the State in all India perspective under EoDB; and

Whereas all the above noted citizen centric online services have been developed in the e-District Portal (www.edistrict.wb.gov.in/PACE) of the State and are available for the citizen for full-fledged use;

Therefore, considering all aspects of the above noted online services in the e-district portal and after imparting necessary training/orientation to the officials of the Municipalities as noted below, it is hereby decided by this Department that Chairman/Chairperson/Administrator of the following Municipalities shall provide all the above noted Online Services to the applicants(citizens) only through the Online System by using e-District Portal w.e.f. 01st March, 2020. It should be ensured that all the applicants (citizens) are provided services through Online without physical touch point for document verification and payment and also within the time frame specified under WBRTPS Act, 2013.
