No. 806/MA/O/C-4/3R-4/2015

In exercise of the power conferred by Section 118 of the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) the Governor is pleased hereby to make the following amendments in the Guidelines in relation to enlistment of Profession, Trade and Calling in the Municipalities issued under this Department notification No. 569/MA/O/C-4/3R-4/2015 dated, Kolkata, the 19th day of August, 2015 (hereinafter referred to as the said Guidelines):-:

Amendments

In the said Guidelines, -

- 1) In Clause 3(1),
 - i) After the words "Annexed at Annexure III", the words "or may apply through online mode" shall be inserted;
 - ii) For the words "along with the documents mentioned in Clause 4 and also with a fee", the words "along with the documents mentioned in Clause 4 or notified in the web portal, and also with an application fee" shall be substituted;
 - iii) For the words "for which the enlistment has been applied for and the total amount of such fee for more than one year shall be calculated on the basis of the annual fee as specified in Annexure I, against the respective Profession, Trade and Calling.", the words " for which the enlistment has been applied for, and the total amount for such application for more than one year shall be calculated on the basis of the application fee as specified in Annexure I, against the respective Profession, Trade or Calling plus the annual fee(s) or charge(s), for providing different municipal services such as supply of water, cleansing of sewerage, disposal of solid wastes and such other fees or charges, as may be specified by the municipality at the time of disposal of the application.", shall be substituted.
- 2) For clause 5, the following clause shall be substituted:
 - "5. Issue of Certificate. (1) The Executive Officer of the Municipality, or in his absence, the officer of the Municipality authorized in this behalf, after examining the application, specified in clause 3 or Clause 7, shall, within 15 days from the date of receipt of the application, issue a Provisional or Permanent Certificate of Enlistment, as the case may be, to the applicant concerned or reject the application if it is not in order, through online mode or otherwise.
 - (2) In the case of rejection of any application the Municipal Authority shall refund the amount, if any, deposited by the applicant along with the communication of such rejection, through online mode or otherwise."

- 3) For clause 7, the following clause shall be substituted:
 - "7. Modalities for making online applications for Enlistment of Profession, Trade and Calling.-Notwithstanding anything contained in this guidelines, the issue relates to applying for enlistment and modalities for issuance of Certificate of Enlistment may also be guided by the following provisions:
 - (1) Applications for Provisional and Permanent Certificate of Enlistment shall be made online through WB e-district portal (http://edistrict.wb.gov.in/PACE) for micro, small enterprises and textile industries or through Silpa Sathi Single Window Portal (https://eodb.silpasathi.in) for large industries.
 - (2) In the cases where any or all necessary statutory clearance remain pending, the applicant may apply for Provisional Certificate of Enlistment, and where all the statutory clearances are available, the applicant may apply for Permanent Certificate of Enlistment.
 - (3) Within fifteen days from the date of receipt of any application, received through the web portals, mentioned in point (1), the Executive Officer of the Municipality, or in his absence, the officer of the Municipality authorized in this behalf, shall issue Provisional Certificate of Enlistment except for trades/businesses specifically prohibited like multi-level marketing, chit fund, hazardous industries, immoral or illegal trade/business etc. as notified by the Government from time to time, and shall communicate their approval to the applicant, and on receipt of intimation, the Provisional Certificate of Enlistment shall be received by the applicant through the web portals, mentioned in point (1) only after depositing the requisite fees, as calculated in Clause 3(1), through online method.
 - (4) In the case of receipt of the Provisional Certificate under point (3), the applicant shall obtain all statutory clearances based on this Provisional Certificate of Enlistment, and shall apply for Permanent Certificate of Enlistment through the same route as mentioned in point (3). The concerned Municipality will do the necessary scrutiny and within fifteen days from the date of receipt of the application, Permanent Certificate of Enlistment will be issued except for trades/ businesses specifically prohibited (like multi-level marketing, chit fund, hazardous industries, immoral or illegal trade/ business etc. as notified by the Government from time to time), for a maximum period of three years. The applicant shall be provided Permanent Certificate of Enlistment online, through the web portals, as described in Point no.1, after depositing requisite fees.
- 4) For Annexure –I and Annexure II appended with the said guidelines, the following Annexure shall be substituted:

Appendix II

Few Definitions & Clarifications

1. ATM BANKING (OFF SITE/ON SITE): ATM counters located within or attached to the Banks are the "ON SITE ATM" counters; ATM Counters standing alone, separately at a distance from the Banks are the "OFF SITE ATM" counters.

2. Schools or Colleges or Institutions, which take help of mechanical and/or electrical and/or electronic instruments/gadgets or use chemical reagents for imparting vocational training and/or academic coaching,

- will be considered as COMMERCIAL SCHOOL/COLLEGE/TUITION IN GROUP (TECHNICAL). However, COMPUTER TRAINING INSTITUTION needs to be treated separately.
- 3. Institutions imparting vocational training and/or academic coaching without taking help of any sort of instrument and/or chemical reagent are the COMMERCIAL SCHOOL/COLLEGE/INSTITUTION (NON TECHNICAL). Centers, which train only Type Writing & Shorthand, will be considered as COMMERCIAL SCHOOL (NON TECHNICAL).
- 4. <u>The institutions engaged in imparting training</u> in subjects of art & culture (e.g. fine arts, music, dance & alike) are to be considered as ORGANISATION FOR PERFORMING/VISUAL ART.
- 5. <u>PRIVATE SCHOOL/COLLEGE</u> is different from "COMMERCIAL SCHOOL/ COLLEGE/TUITION IN GROUP".
- **6.** There is a separate provision for NURSERY SCHOOL/CRECHE. These are not to be confused with "PRIVATE SCHOOL/COLLEGE" or with "COMMERCIAL SCHOOL/COLLEGE/TUITION IN GROUP".
- 7. A shop, having its area more than 500 Sq.Ft. and retailing Fast Moving Consumer Goods (both food & non food) along with other daily needs like garments, footwear, bedding goods etc. and also electrical & electronic goods, cosmetics and many others, are to be treated as DEPARTMENTAL STORE....
- 8. PROFESSIONAL(S) (WITH CHAMBER) (in case of Doctor/Physician): If only one physician attends the chamber and the Licensee & the attending physician are same person
- 9. <u>DOCTOR'S CLINIC</u>: If only one physician attends the clinic and the Licensee & the physician are two different persons. In such case a declaration from the attending physician regarding this fact accompanied by his/her IMA Registration No. is necessary.
- 10. DOCTORS' POLYCLINIC: If more than one physician is attending a clinic and the Licensee may be one or more of the attending physicians or a different person. In such case a declaration from the attending physicians is required stating this fact along with their IMA Registration Numbers.
- 11. PROFESSIONAL(S) (WITH STUDIO): This studio is different from photography studio. This is actually workshop of visual artists like painters, sculptors etc.. This should not be confused with "WORKSHOP/FACTORY ...".

Appendix III

GENERAL PROCEDURE TO BE FOLLOWED FOR EFFECTING ANY CORRECTION / CHANGE OF CE:

For smooth running of the operations related to Renewal of Certificate of Enlistments and for better maintenance of the Licensee Database, procedures related to the matters mentioned below for the Licensee will be as follows:

CORRECTION:

Any erroneous information, printed in the Demand Notice, will be corrected at the Head Quarter and unit offices as per jurisdiction so that digitized data are rectified on-line. For correcting erroneous information printed in the Demand Notice, the Certificate holder will be required to bring the current year's Demand Notice and the previous year's Certificate of Enlistment (Trade License), both in original. Corrections involving change in Demanded Fees Payable must be done before payment of the same.

CHANGE: (MINOR CASES)

Change of any information of a Trade/Business of minor nature like change of area director, partner name and alike will be done according to the following manner:

The Certificate holder will apply in a plain paper enclosing photocopies of all supporting documents for the changes sought for and the photocopy of the last Certificate of Enlistment at the Location Office where the Ward of his/her/their last Certificate of Enlistment belonged. After proper inspection by the department, necessary change can be done in Certificate of Enlistment. Any application for such change is to be submitted before License department by 15th March of every financial year. All changes will be given effect on payment of applicable charges.

CHANGE: (MAJOR CASES)

Changes of any major nature like change of firm/company name, proprietor, address, nature of trade, status (proprietor to partner and vice versa, Private Ltd to Ltd and alike) are treated as major changes. In these cases licensee will have to obtain new CE after surrendering/Closure of the existing CE on Payment of all necessary dues and charges.
