WHEREAS in the Urban Local Bodies, Health Officers are entrusted to oversee Health, Immunization Programmes and Vector Borne Disease Control Programme, etc. of the Urban Local Bodies, this responsibility includes supervision of primary health care system of the Urban Local Bodies presently in vogue, supervision of health centres, maternity homes and hospitals run by the Urban Local Bodies as well as to oversee implementation of various health related Government programmes in the Urban area. Apart from this the Health Officer also acts as the Birth and Death Registration Officer as per provisions of the Births and Deaths Registration Act.

AND WHEREAS out of 124 Urban Local Bodies (leaving aside Kolkata Municipal Corporation), the post of Health Officer has been created in only 61 Urban Local Bodies (one post for each Urban Local Body). During the passage of time, out of 61 posts, 45 posts of Health Officers are lying vacant for sometime past due to retirement of doctors.

AND WHEREAS due to age long vacancy to these posts of Health Officers, the concerned Urban Local Bodies have approached time and again to the UD&MA Department for posting of Health Officers.

AND WHEREAS a proposal for filling up of 45 vacant posts of Health Officers have been moved to State Cabinet after getting concurrence of Finance Department and the said proposal has been approved by the Cabinet in its 34th Meeting held on 27.11.2017 subject to that:

- (a) Filling up of 45 (forty five) vacant posts of Health Officers under different Urban Local Bodies shall be entrusted with the Municipal Service Commission constituted under Kolkata Municipal Corporation; and
- (b) The recruitment procedure of Health Officer enshrined in the West Bengal Municipal Employees' Recruitment Rules, 2005 as per latest amendment shall be followed for such engagement.

NOW, THEREFORE, in exercise of the powers conferred by sub-section (5A) of section 26 of the Kolkata Municipal Corporation Act, 1980 (West Ben. Act LIX of 1980) (hereinafter referred to as the said Act), the Governor is pleased

hereby to determine that the Municipal Service Commission, constituted under section 26 of the said Act, shall select the personnel for the 45 no. of posts of Health Officers under different Urban Local Bodies as per vacancy position in the following table:
