**NOTIFICATION**

Dated, Kolkata, the 6<sup>th</sup> July, 2021

WHEREAS it appears to the Governor that the town of Maynaguri in the district of Jalpaiguri (hereinafter referred to as the said town)—

- (1) contains a population of 45,045 which is not less than 30,000 inhabitants;
- (2) has a density of population of 7094.82 per square kilometre which is not less than seven hundred and fifty inhabitants per square kilometre of area; and
- (3) has an occupational pattern of 80% which is more than one half of the adult population who are chiefly engaged in pursuits other than agriculture;

AND WHEREAS it appears to the Governor that the said town fulfils the conditions under section 3 of the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) (hereinafter referred to as the said Act), for being constituted a Municipal area under the said Act;

AND WHEREAS by this Department's notification No.221/UDMA-15011(19)/3/2020-LS- MA SEC dated the 11<sup>th</sup> day of February, 2021, published in the *Kolkata Gazette Extraordinary*, dated the 11<sup>th</sup> day of February, 2021 (hereinafter referred to as the said notification), the Governor has declared his intention to constitute the said town, consisting of the land as described in the Schedule below, a Municipal area under the said Act;

AND WHEREAS the period of thirty days from the date of publication of the said notification in the *Official Gazette*, for submitting by any inhabitant of the said town his objection or suggestion, if any, to the State Government has expired and no objection or suggestion has been received during the period as aforesaid;

NOW, THEREFORE, in exercise of the power conferred by section 6 of the said Act, the Governor is pleased hereby to constitute the said town consisting of the land, the description of which has been specified in the Schedule below, a Municipal area namely, "Maynaguri Municipal Area" in the district of Jalpaiguri :-
