WHEREAS the State Urban Development Agency (hereinafter referred to as SUDA) was formed as a registered Society under the West Bengal Society Registration Act, 1961 in terms of Municipal Affairs Department notification No. 266/C-10/3S-34/90 Pt. IV dated 27th day of May, 1991;

AND WHEREAS the Change Management Unit (hereinafter referred to as CMU) was formed as a registered Society under the West Bengal Society Registration Act, 1961 in terms of Memo No. CMU-47/2003 dated 9th day of June, 2003;

AND WHEREAS the SUDA and the CMU while administering several programmes and reforms activities separately, they are facing difficulties to keep pace with the changing nature of implementation of several Urban Development Programmes and Urban Reforms activities, which need an integrated mission mode approach converging relevant components of several programmes and it has been decided in principal by Urban Development and Municipal Affairs Department for re-structuring of SUDA by way of subsuming CMU with SUDA and retain a total 93 (ninety three) sanctioned posts of SUDA and CMU considering present manpower position;

AND WHEREAS the proposal for merger of CMU with SUDA has been accorded approval by the Finance Department vide their UO No. Group P2/2017-2018/0118 dated 05.05.2017 subject to Cabinet approval and subsequently the proposal has been approved by the State Cabinet in the 23rd meeting held on 29th day of May, 2017 vide Cabinet Sectt. U.O. No. CAB(D) – 376 dated 30.05.2017;

NOW THEREFORE, Governor is pleased hereby to merge SUDA with CMU with immediate effect for avoiding Duplication of efforts/activities and delay in activities, better Coordination/liaison with the ULBs, strengthening monitoring System of development activities in Urban Local Bodies, providing a Single Window access of Urban Local Bodies for all the services and development activities and strengthening E-governance/IT related activities. After merger, the re-organised SUDA will retain total 93 (ninety three) sanctioned posts of SUDA and CMU detail of which is shown in Annexure – I and the summary of the Cadre Posts is shown in Annexure – II separately. Respective cadre controlling Department shall change the Cadre Schedule in respect of the posts belonging to IAS, WBCS (Exe), WBLS and WBA&AS accordingly.
