PUBLIC NOTICE

Whereas Asansol Durgapur Development Authority (hereinafter to be referred as 'ADDA'), in pursuance of the provisions of Section 31 of the West Bengal Town and Country (Planning and Development) Act, 1979 (hereinafter T&CP Act), has prepared the Land use and Development Control Plan for Durgapur Sub-division (hereinafter LUDCP) which includes Andal, Pandabeshwar, Faridpur-Durgapur and Kanksa Blocks and Durgapur Municipal Corporation.

And whereas in pursuance of the provisions of Section 35 of the T&CP Act, the State Govt. accorded its approval to the publication of notice of preparation of the said LUDCP vide memo no.-423-UDMA-22013(99)/26/2020-DAC SEC-Dept. of UDMA-Part(1) dated 17.03.2023.

NOW THEREFORE, in exercise of the power conferred by Sub-section (1) of Section 36 of the T&CP Act, ADDA hereby publishes the public notice of the preparation of the said LUDCP, inviting objections in writing from any person with respect to the said LUDCP within a period of 60 (sixty) days (from the date of publication of this public notice in The Kolkata Gazette Extraordinary).

The copy of the said LUDCP may be inspected at the concerned Municipal Corporation, Office of Concerned B.D.O. and Panchayet Samities, Durgapur; SDM, Durgapur; & SDL & LRO, Durgapur and at the office of Asansol Durgapur Development Authority, Durgapur in-between 11 AM to 4 PM on any working day, within the aforesaid period.
