NOTIFICATION

WHEREAS, Point No. 72 of the SBRAP, 2022 under EoDB, mandates that an Online System to trigger the change of name is to be implemented in the Online Water Connection / Billing system of the Development Authorities as soon as the property is registered at Sub-Registrar's office;

AND WHEREAS, e-integration of the web portal of online Water Connection/ Billing system of the Development Authorities has already been made with the web portal of the Directorate of Registration & Stamp Revenue viz., "e-Nathikaran"(www.wbregistration.gov.in);

AND WHEREAS, the information of the new registration of any property in the areas of Development Authorities is automatically transmitted from "e-Nathikaran" to the above noted web portal of online Water Connection / Billing system of Development Authorities;

Now, it has been decided by the Government in this Department that for encouraging the urban citizen/ entrepreneurs/industries , to avail the benefit of name change of their water connection/billing immediately post triggering , on registration of deed at the sub registrar's office, resulting in the necessary changes in the concerned data base of the concerned Development Authority, the vendee concerned shall get e-intimation from "e-Nathikaran" for name change in the Water Connection/ Billing system of the concerned Development Authority;

On successful receipt of trigger from "e-Nathikaran" by such vendee and also by the concerned Development Authority , the concerned Development Authority shall make necessary changes in their data base of Water Connection / Water Billing and issue e-intimation to the concerned vendee about the such change of name subject to receipt of requisite fees, through online system , from the vendee concerned.

This notification shall take immediate effect.
