For successful implementation of the initiative and in order to place a Conflict Resolution Mechanism for this purpose, the following procedure shall be followed the light of existing building norms and statutes:

Urban Local Body for providing Building Plan Approval, Occupancy Certificate, Water Connection and Issuance and Renewal of Trade Licence online to the applicant in their respective jurisdiction, shall comply as per with the defined timeline and Designated Authority for this purpose. For any breach in service delivery mechanism, applicant may approach Appellate Authority or Reviewing Authority, as the case may be, for this purpose in the table below:
