
Technical Committee for Tender Evaluation of Online Data Acquisition, Monitoring & Control System (OCEMS)

As per the mandate of Hon'ble NGT, the installation of Online Data Acquisition, Monitoring & Control System (OCEMS) and setting up of Environmental Laboratories need to be completed at an early date at all the STPs of the State. The Department of UD & MA, GoWB has by its order dated 14th December 2020 designated KMDA to act as the Nodal Agency in this matter and requested to float combined tender on behalf of the other Executing Agencies- KMC, MED along with it.
