Synopsis

The Department of Environment, Government of West Bengal has received the present status report of compliance with regard to the Solid Waste Management from State Urban Development Agency and Panchayat Rural Development Department and also received progress reports of Liquid Waste Management and Utilization of Dedicated Ring Fenced Account from Department of Urban Development and Municipal Affairs Department, Government of West Bengal. In compliance to the order dated 01.09.2022 of the Hon'ble National Green Tribunal, Principal Bench, Government of West Bengal has created the Ring fenced the Account of amount Rs. 3,500 crores and the said compliance report was filed before the Tribunal.

As per the reports obtained from different Stake holders present status is as follows:-Solid Waste Management:- In Urban West Bengal total quantity of Municipal Solid Waste generated and collected is 13,469 TPD to the disposal site. Approximately 62% of waste is segregated for further processing as per Solid Waste Management Rules, 2016 and transported. State policy and strategies along with DPR have been prepared and notified for all 125 ULB's. In West Bengal 123 dumpsite has been identified. Biomining has commenced in 84 dumpsites. Till date 26 dumpsites has been cleared. A detailed report of State Urban Development Agency(SUDA) in the format prepared by the Central Pollution Control Board is annexed as ANNEXURE - A.

The compliance report of the Panchayat and Rural Development Department, Government of West Bengal with regard to Solid Waste Management is annexed as ANNEXURE – B.

Liquid Waste Management :- Presently in West Bengal 1749.6 MLD liquid wastes are being treated through 46 STPs and East Kolkata Wetland. 10 STPs of 192.6 MLD is under construction and 6 STPs of 246.7 MLD is under renovation. There are also 30 STPs of 691 MLD capacity, under proposal or tender stage.

Utilization of Ring Fenced Fund: Till date out of Rs. 3,500 Crores, Rs. 46.55 Crores has been spent for the purpose of Solid Waste Management and Liquid Waste Management as per direction of Hon'ble National Green Tribunal.

Report of Urban Development and Municipal Affairs Department, Government of West Bengal regarding Liquid Waste Management and Utilisation of Ring Fenced Fund is annexed as ANNEXURE- C.

Updated status report on the Ring Fenced Public Fund Account as per directions of the Hon'ble NGT in O.A 606/2018 dated 01.09.2022

In compliance with the direction of the Principal Bench of the Hon'ble NGT in the order dated 1st September, 2022, Finance Department had accorded sanction vide U.O No.3406 dated 28.10.2022 for opening of Ring Fenced Public Fund Account by depositing Rs.3500 crore as the compensation for damage to the environment due to violation of the relevant sections of the NGT Act in the State. The said account is to be operated as per directions of the Chief Secretary and utilized for restoration measures, including preventive discharge of untreated sewage and solid waste treatment/ processing facilities, as per appropriate mechanism for planning and execution in pursuance of the aforesaid order of the Hon'ble NGT.

Finance Department had further permitted to transfer this fund to the Public Account of SUDA (Solid Waste Management fund) as a separate Ring Fenced Account. Fund released by the Finance Department is specified in the U.O no.3405, 3406 & 3407, all dated 28.10.2022. Accordingly, SUDA had opened a Ring Fenced Public Fund Account with the PAO-III as a separate Deposit Account under the scheme description 'Solid & Liquid Waste Management Fund", for depositing Rs. 3500 Crore in pursuance of the Order.

The Finance Department (Gr-N) vide U.O. No. 3406 dtd. 28.10.2022 had opened new heads of account '8448-00-120-Other funds-159-Solid and Liquid Waste Management Fund-07-Deposit [Receipt side]" and '8448-00-120-Other funds-159-Solid and Liquid Waste Management Fund-23-Wthdrawal [Disbursement side]" towards deposit of this Rs. 3500.00 Crore.

Till date out of this Rs 3500 crores, Rs 46,55,28,351 (Rs 46.55 crores) has been spent for the purposes as mandated by the order of Hon'ble NGT and the present balance is Rs 3453,44,71,649 (3453.45 crores).

Liquid Waste Management

At present, the STPs for Liquid Waste Management are getting constructed out of the funds from NMCG, AMRUT, State Fund. Fund from this ring fenced account will be utilized for future purposes as and when required.

Minutes of the Meeting on the progress of Liquid Waste Management and Legacy Waste Management in West Bengal under the Chairmanship of Hon'ble Chief Secretary, West Bengal.

Date: 14/02/2023 at 10:30 A.M.

Venue: 13th Floor, Conference Hall, Nabanna, Howrah.

Hon'ble Chief Secretary welcomed all the Officers participated in the meeting through physical and virtual mode (List enclosed) and initiated the discussion. He asked Nandini Ghosh, IAS, Program Director, WBSPMG to start presentation with particular reference to the decisions taken and instruction given in the last Meeting held on 7.11.2022.

The decision taken in the Meeting are as follow:

 Preparation of Master Plan for Urban areas in West Bengal for Liquid Waste Management keeping in view the projected population in 2037:

A Master Plan for the State of West Bengal for Sewerage Generation in Urban areas vis-à-vis gap between existing and Planned Treatment Capacity considering the projected Urban population in 2037 and construction of STPs, FSTPs from funding under NMCG, AMRUT, SBM II & State funding for mitigating the gap in a phased manner, is decided to be prepared.

Action-WBSPMG and KMDA

2. Projects sanctioned under NG II of NMCG Program in the State of West Bengal:

Program Director, WBSPMG stated that there is a budgetary provision for West Bengal for the year 2022-23 for a sum of Rs. 2885 Crore out of which Rs. 1020.77 Crore has already been sanctioned under different Projects. Projects for Rs. 1108.07 Crore has been submitted with the NMCG and it is under their consideration. The DPRs for balance fund of Rs. 751 Crore is being submitted to NMCG by 31st March, 2023.

Action-WBSPMG and KMDA

3. Status of House to House Connection:

60% of the work of House to House connection for the six numbers of functional STPs have been completed and balanced 40% work is under progress. Department of UD &MA has prayed some more time before Chief Secretary for the balance execution. Principal Secretary, UD & MA Department, pointed out that the matter of House to House Connection is dealt with by the ULBs out of the State Fund sanction.

Action-Department of UD & MA and KMDA

4. Re-use of Treated Water:

The matter of re use of Treated Water was discussed and it is informed by the Program Director, WBSPMG that as on date 20% of Treated Water is in use now for activities like Gardening, Pisciculture, Road Washing, Car Washing. WBSPMG has been conducting intensive Mass Awareness Program for promoting the use of treated water for the above mentioned use, so that the valued potable drinking water can be saved.

Action-WBSPMG

5. Mandatory display of Design Parameter:

Design Parameter are being displayed in STP sites, so that the real time water quality data can be compared with them. Also, the work of integrating the Static Data and Design Parameters in the Paribesh App of WBPCB should be taken into priority.

Action-WBSPMG and WBPCB

6. In course of Discussion the Hon'ble Chief Secretary directed to look after the following few issues for execution:

i) Solar Power Plant:

Chief Secretary pointed out that today is the time for using Solar and non-conventional Energy as these are pollution free and renewable. We have to explore the possibility of setting up of Solar Energy Plant in all the existing and forthcoming STPs and FSTPs mandatorily. He also said that by installing Solar Energy Plant the expenditure of Energy for O&M Phase can be reduced considerably.

ii)Use of Aerobic Bacterial Technology in STPs:

MS WBPCB stated that the result of charging of Aerobic Bacterial Technology in STPs, Pumping Stations, Septic Tanks on pilot basis is quite satisfactory and in the long run it will help reduce Faecal coliform to a large extent. The use of this technology can be promoted commercially and to start with, it may be used in the large housing complexes, hospitals and later on Municipalities can be included in a phased manner.

Action-Department of UD & MA and WBPCB

7. Legacy Waste Management:

The status of Legacy Waste Management was presented by the PD, WBSPMG and the Chief Secretary directed to complete the work in all pending site early. He expressed his concern on the generation of RDF from the Legacy Waste site. He directed that the Agency should take care of the RDF removal immediately otherwise penal action will be taken against them. He also pointed out to talk with the Cement Industries for use of RDF as fuel.

8. Incremental Progress since last review meeting held in November, 2022:

The Incremental Progress achieved on the work done under different projects since the last review meeting held in November, 2022 were discussed and the progress was found to be satisfactory and the same is to be maintained.

9. Status of STPs, FSTPs under Bidding Stage in West Bengal:

The status of STP, FSTPs under Bidding Stage in West Bengal were discussed and the Chief Secretary directed to complete the work keeping in view the targeted timeline.

Minutes of the Review Meeting on Solid Waste Management for discussion on several issues of solid waste management

In the Chair : Chief Secretary to Government of West Bengal

Meeting Date : 14th February, 2023

Meeting Venue : Chief Secretary's Conference Hall (13th Floor), Nabanna

Chief Secretary to Government of West Bengal chaired the meeting.

At the outset, he welcomed all the members present and explained the discussion points of the meeting. A threadbare discussion was held regarding the agenda points and following decisions were taken:

- 1. It was decided that the Agencies engaged for Bio-mining and Bio-remediation of legacy waste shall be instructed to dispose of the Refuse Derive Fuel (RDF) converting it to Improved RDF.
- 2. UD&MA Department has engaged Administrative Staff College of India (ASCI), Hyderabad as consultant for preparation of DPR on setting up of Waste to Energy Plant & Bio-CNG for Kolkata MC, Howrah MC and Bally Municipality. It was decided that tender will be floated within 1st week of March, 2023 for engagement of agency. Within July, 2023 the contract shall be awarded to the agency for starting the implementation of the project. It was further decided that within 20th February, 2023 land shall be identified for this purpose at Kolkata MC, Howrah MC, Siliguri MC, Bankura, Malda and Barrackpore. Within August, 2024 the processing shall be started developing the infrastructure.
- 3. It was decided that special emphasis will be given on city cleanliness by way of ensuring 100% segregated collection and transportation and enforcing the legal directions. In this regard a SOP should be developed for ranking the cities and a competition shall be initiated from State Level initially for intra wards and then for intra ULBs and accordingly an incentive scheme shall be designed. West Bengal Pollution Control Board (WBPCB) will provide the fund for this competition and incentives.
- 4. It was decided that an assessment shall be made on legacy and fresh cow dung (gobor) generation throughout the state, and identify 4-5 places like Haringhata, Dankuni etc. for setting up Gobor Gas Plant in PPP model. WBPCB shall work out on the best model already being implemented in the State and the Country what setting up Gobor Gas Plant in PPP model. The target should be setting up 4-5 Gobor Gas Plant within August, 2024.
- 5. It was decided that UD&MA Department should re-visit for improved town planning/urban governance. With no other issue for discussion the meeting ended with vote of tanks to and from the chair.
