MEMORANDUM

The need of providing various services in Municipal areas through the Online mode in view of the Ease of Doing Business (EoDB) Project has been under active consideration of the State Government for some time past and in view of the EoDB requirements, the State Government has decided to introduce **Permission for Sewer connection for industrial buildings in Municipal areas** through online mode only and accordingly it has been decided that all the applications for the above purpose will be submitted by the applicant through online mode only and the permission will be granted by the concerned ULB also through online mode only.

For successful implementation of the initiative and in order to place a regulatory mechanism for the purpose, the following man date shall be followed by all the Urban Local Bodies in the State of West Bengal while issuing permission of road cutting in the ULB areas.

- i. All applications are submitted online.
- ii. All payments of fees including application fee to be deposited online.
- iii. Tracking the status of application online.
- iv. Down load the finally signed certificate/permission by the ULB.
- v. Online verification of the genuineness of the permission by any third party.
- vi. The Urban Local Body in line with the notification issued under West Bengal Right to Public Service Act defining time line for Permission for Sewer connection for industrial buildings in Municipal areas shall provide the same for this purpose within 15(fifteen) days upon receipt of online application with valid documents and requisite fees of the charges as already determined by the concerned ULB for the purpose.

This order will take immediate effect.
