In compliance of the order of Hon'ble NGT dated 31-01-2022, the following steps have been taken:

1. A Committee has been constituted under the Chairmanship of Hon'ble Chief Secretary, Government of West Bengal vide Order No. 10/Law/C-12/Misc/NGT/2016/3S-2016 dated 11.03.2022 to review the progress of different pollution abatement work going on for the Mahananda River.
2. For the purpose of smooth and timely execution of the Sewage Treatment Plant (STP) Projects for the Mahananda River a Project Management Unit (PMU) at Siliguri was constituted vide Memo No. 04-SC(NG) dated 25.01.2022 and on 29.03.2022, vide Order No. 54/UDMAQ-11014(11)/5/2020 dated 29.03.2022, Mukhlesur Rahaman, Executive Engineer (Civil), presently attached to the office of the Secretary, Municipal Engineering Directorate is assigned with the charge to act as the Nodal Executive Engineer of the Project Management Unit (PMU) for Mahananda STP Project.
3. Administrative Approval for the Project Rejuvenation and Augmentation existing waste Stabilization Pond (WSP) and its allied work of STP-III for Jorapani and Fuleshwari River and STP-II for Eastern Side of Mahananda River in Siliguri, West Bengal has been accorded vide Memo No. GO2122011609UM dated 30.03.2022 amounting to Rs. 806197697/- (Eighty Crore Sixty One Lakh Ninety Seven Thousand Six Hundred Ninety Seven Only) manner of disburse. The order is issued with the concurrence of Finance Department of Urban Development and Municipal Affairs Department, Government of West Bengal vide U.O No. AA2122034759FDGRR dated 30.03.2022, the details are given in the table below :-
