Vineet Dhingra, deposited as permission fee for assignment of sub-lease of the Office Unit No-2, 8th floor, DN-52, Sector-V, Salt Lake with super built up area measuring 5514 sq ft and 5(five) car parking space.

I am directed to say that in response to the application dated 16.06.2017 of M/s. Vineet Dhingra, the sub-lessee of Unit No-2, 8th floor, DN-52, Sector-V, Salt Lake, this Department vide G.O. No. 487-UD, Dated 16.02.2018 cancelled the permission Order No. 3197-UD/7L-34/95(Pt) Vol-4, Dated: 29th July, 2016 for assignment of the abovementioned office Unit to M/S Ganpati Exim Inc. with the request to apply to this Department for refund of the permission fee of Rs. 7, 28, 936/- (Rupees seven lakh twenty eight thousand nine hundred and thirty six only) after deduction of administrative charges as admissible.

In compliance with the said orders, M/s. Vineet Dhingra vide letter dated 23.02.2018 applied for refund of the permission fees deposited against cancellation of permission order of transfer the above mentioned space. The matter was referred to the Finance Department, Group –R for according concurrence to the refund of the above mentioned permission fee. The Finance-Group T vide U.O. No. Group T/2018-2019/1180 dated 09/01/2019 opined that " We may accord concurrence towards refund of Rs. 7.28,936/- under the head of account "0217-60-800-001-20" to M/s Vineet Dhingra provided that no service has been availed by the depositor."


