ORDER

Sub: Permission in favour of the lessee Aajkal Publishers Pvt. Ltd. for post-facto regularisation of assignment of SBUA 3381 sq. ft. and car parking space 148.50 sq. ft. along with proportionate undivided share of land to M/s Shrinathji Barter Pvt. Ltd. for Unit No:ESSI-301 at 3rd floor of the premises at plot no: BP-7 Sector-V., Salt Lake, Kolkata-700091 for IT/ITeS purpose.

WHEREAS the lessee **Aajkal Publishers Pvt. Ltd.** vide their letter, dated -11.01.2024 applied for post-facto regularisation of assignment of SBUA 3381 sq. ft. and car parking space 148.50 sq.ft. along with proportionate undivided share of land in favour of **M/s Shrinathji Barter Pvt. Ltd.** in respect of Unit No: ESSL-301 at 3rd floor of the premises at plot no: BP-7, Sector-V, Salt Lake, Kolkata-700091 for IT/ITeS purpose.

AND WHEREAS the DPR of the above mentioned proposed transferee has been approved by the WBEIDCL for utilization on IT/ITES purpose;

AND WHEREAS in terms of this Department's order No. 492-UDMA-27012(11)/17/2024-LMNR SEC Dept. of UDMA, dated-18.06.2024, the lessee has deposited the necessary permission fees for post-facto regularisation of assignment of SBUA and car parking space with proportionate undivided share of the leasehold right of land as shown against the said company as mentioned below:-

Ltd for assignment of the SBUA of 3381 sq. ft. along with car parking space of 148.50 sq. ft. with proportionate undivided share of land to **M/s Shrinathji Barter Pvt. 
