ORDER

Subject: Permission for assignment of lease hold right of area measuring 848 sq. ft at unit no. 01 on 14th floor of the building along with car parking space 1 no. open surface parking area measuring 135 sq. ft. in favour of Aarushi Saria at premises no. EM-03, Sector- V, Salt Lake, Kolkata-700091.

WHEREAS this Department allotted 3.4977 acres land vide offer of Allotment no. 3895-UD/O/M/SL(AL/NR)/7L-37/95 dated 01.10.2001 to M/s. Techna Infrastructure Private Limited for the purpose of setting up Software Development Project;

AND WHEREAS the Executive Engineer, Design, SLR &D.C, intimated that after actual measurement of the Plot No. 03, Block – EM, Sector – V, Salt Lake had been found to be 210.75 Cottahs;

AND WHEREAS a Lease Deed was executed on 23.05.2002 and registered on 17.06.2002;

AND WHEREAS possession certificate was issued in favour of M/s. Techna Infrastructure Private Limited vide possession Certificate No. B-273, dated 13.08.2002;

AND WHEREAS a Deed of Rectification was executed on 24.05.2006 to allow the Techna Infrastructure Pvt. Ltd. to sublease/rent out the surplus built-up space in the building to be constructed on Plot No. EM-03, Sector-V, Salt Lake;

AND WHEREAS Techna Infrastructure Pvt. Ltd. vide their letter dated 29.09..2023 submitted a proposal for transfer of super built up area measuring 848 sq. ft. at unit no. 01 on 14th floor of the building along with car parking space 01 no. open surface parking area @ 135sq. ft. in favour of Aarushi Saria at premises no. EM-03, Sector- V, Salt Lake, Kolkata-700091 for use on IT/ITeS purpose.

AND WHEREAS the DPR of Aarushi Saria for IT/ITeS purpose has been approved by the Department of I.T. & E, Government of West Bengal;

AND WHEREAS in terms of this Department's demand notice no. 785-UDMA-27012(11)/93/2023-LMNR SEC-Dept. of UDMA, dated 10.11.2023 the Director of Techna Infrastructure has deposited the following permission fee through GRIPS Portal:-


