Ltd. has prayed to this Department for transfer of 100% leasehold right along with G+2 storied building constructed thereon in favour of Institute of Engineering and Management Trust for "IT based education & training";

AND WHEREAS WBEIDC Ltd. (Webel) vide letter no.01:webel: 049:22:4491, dated 25.3.2022, informed this Department that the IT/ITeS project of these proposed assignees found viable and may be consider favorably;

AND WHEREAS a hearing was held on 27.05.2022 with M/s Shockley Hall Private Ltd.

AND WHEREAS the proposed assignee has made declaration at the time of hearing that they will utilize the plot for IT product development in AI and IOT, IT based training and education in AI, IOT, Cyber Security, Research and Development in emerging IT Technologies;

AND WHEREAS further this Department referred this proposal to IT & E Department for 'Electronic Industry' and "IT based education & training" may be considered as change of use / change of purpose;

AND WHEREAS IT Department has informed that IT based education and training facility shall not be considered as part of IT/ITeS industry. However on the other hand, electronics industry shall be considered as part of the IT/ITeS industry;

AND WHEREAS this Department has considered that it is the change of purposed of land from Industrial to Institution purpose.

AND WHEREAS this Department's issued a demand notice bearing 791-UDMA, dated 16.11.2022 in terms of notification nos. 5081-UD/O/M/SL(AL/NR)/8L-08/2004, dated 26.11.2012, 3540- UD/O/M/SL(AL/NR)/8L-08/2004, dated 13.09.2013. Subsequently a matching demand notice was issued vide memo no. 250/D/1(2), dated 18.11.2022 with the request to the lessee to deposit the permission fees amounting Rs. 1,35,14,130/- for the transfer of the lease hold right of the above mentioned plot of land as well as change of purpose of the land.

AND WHEREAS the lessee has deposited the requisites permission fees through GRIPS portal vide GRN No. 192022230177927711, dated 17.11.2022 and GRN No. 192022230177956271, dated 17.11.2022.
