**Sub: Show Cause notice for violation of Clause 2(6)(a) of Lease Deed dated
23.02.1970 in respect of Plot No.AB-186, Sector-I, Salt Lake, Kolkata**

WHEREAS by a deed of indenture executed between the Governor of the State of West Bengal and you on 23.02.1970, a plot of land being No.186 in Block-AB in Sector-I, Bidhannagar has been leased out to you on the terms and conditions as set forth in the said deed for the purpose of construction of your dwelling house.

AND WHEREAS the delivery of possession of the aforesaid plot was taken over by you on 04.08.1970 vide possession certificate No.200 dated 04.08.1970.

AND WHEREAS in terms of clause 2(6)(a) of the aforesaid indenture you were required to construct your dwelling house thereon within three years from the date of taking over possession as per building rules, failing which the Government reserves the right to resume the aforesaid plot.

AND WHEREAS the survey report submitted by the Surveyor of the department on 01.08.2016 reveals that the plot is still lying vacant.

AND WHEREAS you have failed to construct your house on the said plot of land as yet and thereby violated the aforesaid clause of the aforesaid indenture.

NOW, THEREFORE, you are requested to explain within 30(thirty) days from the date of issue of this letter as to why the aforesaid plot of land leased out to you will not be resumed by the Government.
