ORDER

Sub-Register, Bidhannagar, Bikash Bhavan, Salt Lake City, Kolkata-700091/Additional Registrar of Assurances-IV, Kolkata, within 60 days from date of issue of this order. After registration of the Deed, a certified copy of the same should be submitted to this office at the earliest for mutation/updating the Government records etc.


