2. Selection Procedure:

Interview of the applicants for the post of Technical Member of Municipal Building Tribunal will be conducted by a Departmental Selection Committee headed by Sr. Special Secretary of the Department of Urban Development & Municipal Affairs, Government of West Bengal at Nagarayan, 4th Floor, DF 8, Sector I, Salt Lake, Kolkata-700064. Based on the result of the interview, a panel of shortlisted applicants will be drawn up from which appointment to the post of Technical Member of Municipal Building Tribunal under Kolkata Municipal Corporation will be given for such period and on such terms and conditions as the State Government may determine. Contractual tenure may be renewed for further period on the basis of the satisfactory performance but the member concerned shall not hold office beyond 65 years of age. The validity of the panel will be for one year.
