1.9. Termination Notice:

SPMG/ NMCG can cancel the appointment of a consultant at any time, without providing any reason for it. However, in the normal course, it will provide one month's notice to the Consultant. The Professionals can also seek for termination of the Contract upon giving one month's notice to the SPMG/NMCG.

1.10.2 All the received applications are short listed based on requisite eligibility will be called for personal interview on a specified date.

1.10.3 The selection shall be made on the basis of recommendations of Selection Committee constituted for the purpose by the NMCG.

1.10.4 The candidate will be required to produce original certificates in support of fulfilling the eligibility criteria, etc., as to educational qualification and experience during interview and at the time of joining.


