Assistant Engineer (WS), Howrah Municipal Corporation invites E-Tenders (in prescribed form) from reputed resourceful & bona-fide contractors who have [for 1<sup>st</sup> Call] i) Intending tenderers should produce credentials of a similar nature of work, of minimum value of 40% of the estimated amount put to tender during Five (5) years prior to the date of issue of the tender notice Or (ii) Intending tenderers should produce credentials of a similar nature of 2 work each of minimum value of 30% of the estimated amount put to tender during last five (5) years prior to the date of issue of the tender notice. Or (iii) Intending tenderers should produce credentials of one (1) single running work of similar nature of the minimum value of 80% or more and value of which is not less than the desire value at (i) above In case of running works: only those tenderers who will submit the certificate of satisfactory running work from their concerned Executive Engineer of equivalent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e the tenderer. [for 2<sup>nd</sup> Call] (i) Intending tenderers should produce credentials of a similar nature of work of the minimum value of 30% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice or, (ii) Intending tenderers should produce credentials of 2 (two) similar nature of work, each of the minimum valve of 25% of the estimated amount put to tender during 5 (five) years prior to the date of issue of the tender notice or, (iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 75% or more and value at (i) Above: In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned executive engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executive agency, i.e, the tenderer. [for 3<sup>rd</sup> Call] i) Intending tenderers should produce credentials of similar nature of completed work of the minimum value of 20% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or, ii) Intending tenderer should produce credentials of one single running work of similar nature which has been completed to the extent of 70% or more and value of which is not less than the desired value at (i) above; In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e., the tenderer. **Terms and conditions of Annual Maintenance of Pipeline (Ward no – 1 to 50) of Water Supply Department, HMC**



- 1) Agency must have his own office and godown at nearby place within his working zone.
- 2) Agency must keep at least 20 nos. working personnel (skilled, semi skilled, unskilled) & a supervisor having technical knowledge of concerned works.
- 3) A list of worker's (skilled, semiskilled, unskilled etc.) to be submitted along with the tender documents, if selected as a lowest bidder Agency must have to submit their photograph, photo copies of Aadhar Card, Pan Card, Voter Card, phone number of 20 nos. workers as per list submitted during tender.
- 4) Agency must takeover the work within 6 hours after getting intimations from the departments of Water Supply of HMC Head office & Borough Offices as the cases may be.
- 5) Agency must have a capacity to do 3/4 nos. work at the same time at same day by different gang under his control.
- 6) Agency will make arrangements for life insurance of his labour gang altogether. Agency would remain sole responsible and for any incident or accident take place at site during works. HMC will not take any liability of the Agency's staff.
- 7) Agency should keep all materials & equipments ready as necessary at sites to start works immediately.
- 8) If require, work may be taken up /continued at night at a stretch till the work gets completed. Necessary arrangements (lighting, road barriers, signals for traffic movement etc.) must be done by the Agency.
- 9) Before starting the work agency must inform Police personnel, CESC/WBSEDCL & BSNL as per norms.
- 10) Before starting the work agency must keep work order or intimation slip from the concerned Engineers of Water Supply Department of HMC Head office & Borough Offices as the cases may be.
- 11) Agency will look after occurrence of the leaks on a routine basis by his engaged personnel on every day covering all the areas of his entrusted working zone.
- 12) Temporary road restoration works are to be done immediately after completion of works for easy traffic movements.


