The quotation and the aforesaid papers along with the comparative statement will be referred to the office of the Executive Engineer Asansol Division, M.E. Dte., as mentioned above for his examination and recommendation and on the basis of which further action will be taken.

The no. of bore holes and procedure of soil test should be done strictly adhering to the specification laid down as per relevant I.S. code and as per direction and guidance of EIC. The minimum depth of bore hole to be of 30 mtr. and rate should be quoted inclusive all taxes and duties per bore hole both in words and figure and deduction to be done as per usual Govt. norms. But for any reason beyond the control of concerned parties the required depth cannot be reached, then the rate per bore hole will be determined on pro rate basis. The soil test report should contain recommendations regarding the nature, type and design of foundation.

Before submission of quotation, intending Quotationers should inspect the work site and get acquainted with the local conditions and possible difficulties under which the work is to carried out. The relevant site plan may be seen from the office of the undersigned.

The successful Quotationers shall have to execute and agreement within 7 days from the date of acceptance of the quotation in Municipal agreement. The contract document will be available in this office at Rs. 250.00 each and earnest money @2.0% of the total quoted amount is to be deposited in form of Bank Draft on any Nationalized Bank / pay order payable in SBI Bank, Asansol Branch at the time of executing formal agreement drawn in favour of the SECRETARY, Asansol Municipal Corporation.
