TERMS & CONDITONS:

- The agency shall be responsible for guarding & nourishment of the trees including supply of water, manners, spraying insecticides etc. at his own cost for ensuring the growth of coconut trees. After collecting of coconuts at each time plants should be trimmed near the fruit growing zone for effective growth.
- The agency would be entitled to sell the fruits/ or dry leaves of the coconut trees but care should be taken that the trees are not damaged in any way and he will be responsible for any damages to the trees caused due to his negligence. The penalty of Rs. 500/- (Rupees Five Hundred) only per damaged tree will be charged & would be realised from the agency.
