The cost of Quotation document and the EMD as specified in this NIQ shall be paid by online internet bank transfer or NEFT or RTGS (as per GO No. 3975-F(Y) dt. 28.07.2016 of Finance Dept., Govt. Of West Bengal).

Every such Transfer shall be done on or after the date of publish of NIQ. Any Bid without such Transfer of EM (Except exemption as per G.O.) shall be treated as informal and shall be automatically cancelled. have to be uploaded as statutory document.

Online transfer of Earnest Money receipt (Scanned Copy) must be Uploaded with the Technical Bid Documents. Otherwise the Quotation will be treated as non-responsive. The Bidders will have to submit their bid on-line in two cover/folder system containing pre-qualification document (Technical Bid) in one and Financial Bid in another.



## TERMS AND CONDITIONS

- If the agency fails to do the work as per the agreement with the municipality, penal action in the form of forfeiture of earnest money and or security deposit money, as decided by the authority, will be imposed on the agency and the decision of the authority will be conclusive and binding. In this respect, the Chairman, KALNA Municipality shall be empowered to invoke the Earnest Money deposited in favour of him. No price escalation, in any form, within the contract period will be entertained.
- The rate quoted should be inclusive of all cost of transportation, loading, unloading, staking at site within any municipal area of the State of West Bengal, and all Taxes, GST, etc. what so ever
- The Mayor / Chairperson of Municipal Corporation / Municipality shall have power to make any alteration in, omissions from, additions to or substitution for the original specification, drawings, designs and instructions, that may appear to him to be necessary or advisable during the course of execution of the works and the Bidders shall be bound to execute the works in accordance with any instructions which may be given to him in writing signed by the Chairperson Kalna Municipality and such alterations, omissions, additions or substitutions shall not invalidate the works and any altered addition or substituted materials which the tenderer may be directed to supply in the contract in the manner above specified as part of the work shall be supplied or executed by the Bidders on the same conditions in all respect on which he agreed to do the main work, and at the same rates as are specified in the Quotation for the main work.
- Penalty for suppression / distortion of facts:

If any Bidders fails to produce the original hard copies of the documents uploaded or any other documents on demand of the Quotation Inviting Authority within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the Bidders will be suspended from participating in the Quotations on e-Quotation platform for a period of 3 (Three) years. In addition, his user ID will be deactivated and Earnest Money Deposit will stand forfeited. Besides, the Chairman, Kalna Municipality may take appropriate legal action against such defaulting Bidders. The authority may ask to show hard copies of all certificates, company details, partnership deeds etc. etc. as uploaded by the Bidders and allied papers in connection with this Quotation as and when necessary for verification purpose as per convenience of the authority during processing of this Quotation.
