f) **Defect Liabilities Period :** If any damage shall happened to the work for any cause whatsoever or any imperfection become apparent in it at any time whether during its execution of within a period of 1 year from the actual date of completion certificate issued by the Engineer in Charge. The contractor shall make the same goods at his own expense or in default, the Engineer in Charge may cause the same to be made good by other workmen and deduct the expense from any sums, whether under the contract or otherwise that may be then, or at any time thereafter become due to the contractor from the Government or from his security deposit.

i. Full security deposit shall be refunded to the contractor on expiry of one year from the actual date of completion of the work.

g) Select the tender to bid and initiate payment of pre-defined EMD/Tender Fees for that tender by selecting from either of the following payment modes:

- Net Banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI Bank payment gateway.
- RTGS/NEFT in case of offline payment through bank account in any bank.

- i) On selection of RTGS/NEFT as the payment as the payment mode, the e-Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction.
- ii) The Bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his Bank account.
- iii) Once payment is made, the bidder will come back to the e-Procurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.
- iv) If verification is successful, the fund will get credited to the respective Pooling account of the State Government/PSU/Autonomous Body/Local Body/ PRIs, etc maintained with the Focal Point Branch of ICICI Bank at R.N. Mukerjee Road, Kolkata for collection of EMD/Tender Fees.
- v) Hereafter, the bidder will go to e-Procurement portal for submission of his bid.
- vi) But if the payment verification is unsuccessful, the amount will be returned to the bidder's account.


