Moreover, remaining amount of security deposit shall be deducted from the running account bill of the agency to cover up 10%(ten percent) of the total value of the work executed.

Intending tenderers must apply to the undersigned in writing together with documentary evidences in support of their experience and competency to execute such type of works along with valid E.S.I & E.P.F, GST, PAN & P.T., for obtaining permission from undersigned to purchase tender documents for the work . Rates should be quoted in figures as well as in words at percentage above/below or at par within the rates shown in the schedule of the above mentioned work; no tender with price variation clause will be entertained.
