

No.4) in original along with the self attested photo copies of each document and a prayer for purchase of Tender paper addressed to the Chairperson, Guskara, Municipality, P.O – Guskara, Dist- Purba Bardhaman. The application along with the aforesaid papers will be examined by the Engineering Section and thereafter Tender papers will be issued accordingly. Applicants, if found not complying with the eligibility criteria of the Tender, shall not be considered for issuance of Tender paper. Decision of the Guskara Municipal Authority shall be final and binding on the applicants in this regard. The cess will be deducted from the gross bill amount @ 1% including other deduction as usual. The Municipal Authority reserves the right to reject any or all the Tenders without assigning of any reason whatsoever and is not bound to accept the lowest Tender.


