If any defect is found after the completion of the work, agency will be bound to rectify it with the help of other agency of departmentally and its cost will be deducted from the security deposit.

Quality of work may be checked by the Department, at any time, if it is not found in order entire work Bonafied mistakes may be ignored.

In connection with these works, no arbitration will be allowed. Clause No-25 will not stand valid while executing Deduction of Tax shall be as below:-

i) Goods and service tax shall be as per provision GST act-2017

ii) Cess @ 1% (one percent) of the cost of construction works will be deducted from the bills of the contractors on all contractors awarded on or after 01.11.2016 in pursuance with G.O No- 599A / 4M-28 /06 dated -27-09-2006
