Notice Inviting Quotation No 10 of Executive Engineer, Salt Lake Reclamation Division of 2019-20.

Name of Work: Preparation of Detail Project Report for the work, "Repair and rehabilitation of 2 nos 4 storied building viz B-25 & B-26 of Falguni Abasan, Bidhannagar, Kolkata under Salt lake Reclamation Sub Division No II of Salt Lake Reclamation Division of Department of U D & M A."

Time of Completion: 30(thirty) days.

Department of U D & M A, Government of West Bengal intends to renovate of 2 nos 4 storied building viz B-25 & B-26 of Falguni Abasan, Bidhannagar, Kolkata and, for this purpose, the undersigned invites quotation from reputed Consultant having sufficient experience in this field.

1.0 Scope of Activities

The successful consultancy firm will have to prepare Detail Project Report for renovation of 2 nos 4 storied building viz B-25 & B-26 of Falguni Abasan, Bidhannagar, Kolkata under Salt lake Reclamation Sub Division No II of Salt Lake Reclamation Division of Department of U D & M A" as per recommendation at health assessment report submitted by Jadavpur University for B/25. Necessary support required during execution are to be designed and layout drawing to be submitted with DPR. Vetting of this support system, both design and drawing, are to be vetted from reputed education institute. Preparation of all detailed working drawings of the said work and preparation of Bill of Quantities (BOQ) for civil work as per PWD schedule in vogue including rate analyses of items not included in the PWD schedule have to be done. Survey work, if required, to be carried out for preparation of DPR. DPR i.e design, drawing estimate has to be vetted by reputed educational institution. Any modification required after submission of draft DPR or recommended by vetting authority to be done by successful bidder without any additional remuneration. 6 no hard copies and 2 no soft copies of DPR to be submitted.

General Condition

Prayer for issue of papers may be addressed to the Executive Engineer, Salt Lake Reclamation Division, Department of Urban Development & M.A. Intending bidder should apply for bid document in their respective Letter Heads the self-attested photo copy of the following documents.

Registered bona fide, reliable and resourceful consultant agencies/firms *having sufficient experience in execution of similar type of works* may participate in this NIQ: Completion Certificate with schedule will be considered as credential. Work Order will not be considered as credential.

Others: Any other documents found necessary.

Note: Failure of submission of any one of the above mentioned documents will render the bid liable to summary rejection.

1. General Terms & Conditions

- 1. Bids are to be submitted offline within the stipulated date and time as given in the Bid. The bidder shall carefully go through the documents. He needs to fill up the rates in the BOQ, both figure and word.

2. The undersigned reserves the right to disallow participation of any or all the applicants in the EOI, without assigning any reason whatsoever and no challenge against such refusal will be entertained. The applicants will also not be entitled to any compensation for rejection of their prayer for participation in the EOI.
3. In case of sudden closure of office due to reasons beyond the control of the undersigned, the last date and time as indicated hereinafter, will automatically be deferred to the next working day without further notice.
4. Participation in this NIQ deems that the applicant is fully agreeable to abide by all terms and conditions as stated in this notice inviting quotation.
5. Any notice or instruction to be given to the participants under the terms of this EOI shall be deemed to have been served if it has been delivered to his authorized agent (on the strength of authorization) or representative or sent by registered letter to his address as furnished.

8. No conditional bid/offer/proposal shall be accepted.

11. **2% of quoted amount in the form of Bank Draft from any Nationalized Bank is to be submitted by the bidder.**
12. Quotation paper will be issued to the agency having sufficient credential in this field.

14. Special Engineer, Salt Lake Reclamation & Development Circle is the accepting authority of this quotation.

3. All changes in the structural design will have to be done free of cost by the selected bidder/firm during execution or after execution before it put into operation. Also, any changes those are unavoidable must be done by the selected bidder free of cost.
4. Survey, etc. if required to be done by the agency.
5. D P R should be vetted by reputed educational institute.
6. **Expenditure for vetting to be borne by the successful bidder.**
7. Rate analysis of the items, which are not included in PWD schedule to be provided.
8. **The selected bidder/ firm have to submit Detail Project Report 6 (six) hard copies and 2 (two) soft copies to Special Engineer, Salt Lake Reclamation & Development Circle.**
