- Removing of rust with brushing and cleaning the external surface of 10 mm & 12mm thick MS casing Pipes of 200 mm to 700mm internal dia. of pipe as required and other as required applying one coat of approved primer over it and providing 2 coats of anti corrosive, non-toxic paint to all pipes and specials inside as per IS Specification & direction of Engineer in Charge.
- iv) Fabrication of MS Specials viz. reducer, enlarger, tees, bends, puddles, bell mouth out of 12 mm thick MS barrel / MS spirally welded pipe including cutting of the barrel/spirally welded pipe to exact size & shape including supply of 10 mm & 12 mm plate from SAIL / TISCO as per direction of Engineer in Charge.

v) Supplying and laying of 10 mm & 12mm thick MS casing Pipes of 200 mm to 700mm internal dia. of pipe as required and other as required pipe including lowering, inserting and jointing the same MS conduit as per the level and slope as shown in the drawing and as per the direction of the Engineer in Charge and complete in all respect (Final length are finalised as per direction and approval of EIC and approved drawing during execution of work.)

vi) Filling of steel pipes & D.I. Pipes and specials with water by contractor and testing hydraulically the same under a head of pressure as per specification including supply of water and necessary equipments such as blank flanges, gauges, pump etc. required for the testing including providing suitable end thrust block and dismantling and removal of the same after completion of the testing, fixing special type of end cap, blank flanges and removal of the same after completion of the testing, welding, jointing, gas cutting etc. as necessary including of jointing materials, disposal of water after testing etc. all complete as per specification and direction of the Engineer in Charge.

vii) Supply, fitting & fixing different dia.CI Sluice Valve & 100 mm dia CI Air Valve as per requirement with necessary fittings and fixture including cost of 100 mm internal dia seamless steel pipe for as length not exceeding 10 M.

20. Restoration works of all types roads to be done as per enclosed and as per direction and satisfaction of E.I.C.

II) All works are to be done as per instruction of the Authority under whose jurisdiction the road exists if applicable.
