DETAILS OF PROCEDURES / INSTRUCTIONS

The Agency / Agencies having expertise for scrutinising and processing of applications, holding of examinations and preparation of result sheets will be engaged towards filling up of 02 (two) vacant posts belonging to Group 'B' category and 13 (thirteen) vacant posts belonging to Group 'C' category, as already circulated vide our earlier Notification No.- AKM/2373/ Gen.Estb.Emp/ 2016-17 dt.- 03/01/2017 alongwith the instructions annexed thereto.

- 1) The applications for the post of Group 'B' and Group 'C' category should be shorted out of the total applications received in this U.L.B.
- 2) The applications so received for each category should be scrutinised for holding of examination of the eligible candidates of each category after rejection of applications, if any. A statement showing the reason/reasons for rejection/cancellation of applications for each category should be prepared for future cause of action, if any.
- 3) The Agency / Agencies will thereafter set up separate question papers (MCQ and objective) of full marks of 80 (eighty) for each category for the written examination.
