- 2. The empanelment is valid for 2 years subject to satisfactory performance to carry out multi-faceted corporate public relations affairs with immediate effect. The empanelment may be extendable by another year subject to the approval of the competent authority (conditions apply).
- 3. Service should be available all the time as and when required by SPMG.
- 4. The telephone number/mobile number and address of Chief Executive and the concerned representatives of the advertising agency dealing with SPMG should be submitted to the SPMG.

- 5. In emergency, your service is a must even on Sundays and Holidays looking into the magnitude of requirement of the organisation.
- 6. In case of non-acceptance of advertisement order, the same will be given to next agency as per rotation.
- 7. If any agency refuses to accept advertisement on 3 occasions, the name would be deleted from empanelment.
- 8. The agency will attend SMPG office to collect the advertisement within 3 hours of intimation.
- 9. The advertisement bills should be sent to Program Director along with original bills of the newspapers, along with the photo copies of rate card, Service Registration No., VAT registration no., Sales Tax etc.
- 10. Works for exhibition, printing, audio-visual production etc. will be awarded after calling limited tenders from all the empanelled agencies. Enquiries will be displayed on UD Dept.'s website from time to time.
- 11. For qualitative design/artwork submitted by the advertising agency on institutional requirement as directed by Executive Chairperson and Principal Secretary, UD Deptt., Govt. of West Bengal.
- 12. The agency should send confirmation of publication of advertisement in the newspapers within 3 days to the Concerned Officer of SPMG.
- 13. In case of failure to fulfill the terms and conditions and if the service is not satisfactory, SPMG reserves the right to delete the name of the advertising agency by giving a notice of 7 days.
- 14. In case of any dispute between SPMG and the agency, it should be referred to the Principal Secretary, Urban Development Department whose decision will be final. If the decision of the Principal Secretary is not acceptable by the agency, it should be referred to the court of law.
