## 1. SCOPE OF WORKS FOR SUB-SOIL INVESTIGATION (PER SITE):

(I) Mobilization of all tools and plants along with accessories, materials, labour, and supervision etc. at site of work required in connection with boring and testing work including setting up boring rig and shifting to different borehole points etc. and also

- including withdrawal of the same from the site after completion of work complete as per direction of Engineer-in Charge.
- (II) Minimum two nos. of bore hole of atleast 20 metre depth in each site is required.
- (III) Performing laboratory tests on disturbed / undisturbed soil samples as per standard procedure and as per relevant IS Code including tabulation of test results in prescribed proforma as per direction of Engineer- in- Charge.
- (IV) Preparation and submission of report in **3 (Three) copies** giving all relevant information data like site plan, bore log and water table test results, calculation, discussion, suggestion and recommendation in respect of suitable foundation etc. is bound and presentable form complete in all respect and duly authenticated from any Government Engineering College as per direction of Engineer-in Charge.
- 2. In the event of e-filling, intending bidder may download the tender documents from the website: http://wbtenders.gov.in directly with the help of Digital Signature Certificate & necessary earnest money should be remitted through online process as per Finance Department Order No. 3975-F(Y) dated 28.07.2016
- 3.Both Technical Bid and Financial Bid should be submitted in technical and financial folder concurrently duly digitally signed by the Quotationer through the website <a href="http://wbtenders.gov.in">http://wbtenders.gov.in</a>. The documents submitted by the bidders should be properly indexed & digitally signed.
- 4. The Bid should be submitted online on or before the closing date and time given in this e-NIQ.
- 5. The FINANCIAL OFFER of the prospective quotationer will be considered only if the TECHNICAL Documents of the quotationer found qualified by the Quotation Inviting Authority.

# 6. Eligibility criteria for participation in the tender:

- A. (i) Valid PAN issued by the IT. Dept, Govt. of India, Valid Professional Tax Receipt Challan, Trade Licence, Valid 15-digit Goods and Service Taxpayer Identification Number (GSTIN) under GST Act, 2017, are to be accompanied with the Technical Bid document. Income Tax Acknowledgement Receipt of last 3(Three) years needs to be submitted.
- (ii) All categories of intending Quotationers shall have satisfactorily completed as a prime agency during the last 5 (Five) years prior to the date of publication of this Notice Inviting Quotation at least one work of similar nature under the authority of Government Department, Zilla Parisad, Government Undertaking / Statutory Bodies constituted under the statute of the Government.(However it is not mandatory as per order no. 410-A/PW/O/10C-9/14, dt.01.12.2014 by Principal Secretary of Govt. of West Bengal, PWD)
  - (iii) Intending tenderer should have well equipped laboratory for conductive tests as per IS code.
  - (iv) Intending tenderer should have qualified and experience technical personnel of relevant field.
- B. Other terms and conditions of the credentials:
  - (i) Payment certificate will not be treated as credential;
- (ii) Credential certificate issued by the Executive Engineer or equivalent or competent authority of a State / Central Government, State / Central Government undertaking, Statutory / Autonomous bodies constituted under the Central / State statute, on the executed value of completed / running work will be

taken as credential.(However it is not mandatory as per order no. 410-A/PW/O/10C-9/14, dt.01.12.2014 by Pricipal Secretary of Govt. of West Bengal, PWD)

The prospective bidder shall have in their full time engagement experienced technical personal. (Authenticated documents in respect of qualification and engagement shall be furnished for Technical Evaluation)

[Non-statutory documents]

- iii) Neither prospective bidder nor any of constituent partner(s) should have been debarred to participate in tender(s) by the any Department, Government of West Bengal during the last 2 (two) years prior to the date of this NIeQ. Such debarment will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders as per prescribed format without which the Technical Bid shall be treated non-responsive).
- iv) The payment will be made as and when fund is available from State Urban development Agency(SUDA) on recommendation of bill from the end of the E.I.C.
- v) Successful bidders will be required to observe the following conditions strictly:

Adequate safety and welfare measures must be provided as per the provisions of the Building and other Construction Workers' (Regulation of Employment & Conditions of Service) Act, 1996 read with West Bengal Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2004.

No Mobilization Advance and Secured Advance will be allowed.

vi)Bids shall remain valid for a period 120 days from the last date of submission of Financial Bid. If the bidder withdraws the bid during the period of bid validity the earnest money as deposited will be forfeited without assigning any reason thereof.
