He needs to fill up the rates in the BOQ, downloaded for the work, in the designated Cell and upload the same in designated location of Financial Bid. The documents uploaded must be virus scanned and digitally signed using the Digital Signature Certificate (DSC). Bidders should specially take note of all the addendum and corrigendum related to the bid and upload the latest documents as part of the bid.

B) 30% (Thirty Percent) payment would be made during deliberation & presentation of EIA report to the competent authority for their evaluation on issue of NOC. C) Balance 20% (Twenty percent) payment would be made after completion of all compliance reports, deliberation, presentation etc till acceptance/rejection of NOC for the project.
