Executive Engineer, Howrah Municipal Corporation invites e-tenders in prescribed form from reputed, resourceful & bonafide genuine reputed manufacturer or Authorized dealer/ representative (like TATA, BIRLA, ANDHRA SUGAR etc.) of the same, with proper documents of dealership such as different relevant upto date certificates issued by competent Authority etc. having up to date valid PAN card, up to date GST and PT clearance certificates, including license to supply similar type of chemicals & credential for application of their product to similar water treatment plant with attested photocopy and duly signed by the agency with stamp for the work as mentioned below. Originals are to be shown for verification. [for 2nd Call] Intending tenderers should produce credentials of a similar nature of completed work of the minimum value of 30% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or, ii) Intending tenderers should produce credentials of 2(two) similar nature of completed work, each of the minimum value of 25% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or, iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 75% or more and value of which is not less than the desired value at (i) above; In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e., the tenderer. MATERIAL SPECIFICATION & TERMS & CONDITIONS

- 1) Material :** Liquid Poly Aluminium Chlorideinum Chloride (PAC) 10% HB conforming to IS 15573 : 2005. Manufacturer should have Toxicity Reports of PAC 10(HB) tested from ITRC Lucknow or Haffkine Institute for Training, Research & Testing or equivalent for all the relevant tests.
- 2) Supply Schedule :** Initially 100 M.T. to be supplied within a months from the date of supply order and Thereafter 40 M.T. per month shall be supplied subject to availability of storing space or as per direction of E.I.C.
Gross weighing capacity of Howrah Water Works Weighbridge being limited to 30 M.T. each supply (including truck) would be limited to above weight. Consignment weighing above this limit may be sent back. Each supply should contain BIS certificate/ mark. However Supply schedule may be changed by EIC as per requirement.
- 3) Testing :** Testing of any lot of Liquid Poly Aluminium Chloride (PAC) may be done as per direction of E.I.C. as and when required from Govt. / Semi Govt. / Departmental approved laboratory. Necessary fees for sample testing as claimed by the Govt. / semi Govt. laboratory etc. is to be deposited by the supplier before testing.
If any lot found not as per said material specification after testing that will be rejected at the direction of E.I.C.
- 4) Place of delivery:** The materials to be delivered and stacked properly in the godown / tanker of Padmapukur Water Works, at Howrah as directed by E.I.C. or his authorized representative.
- 5) Validity of offer for acceptance:** The offer shall remain valid for acceptance for 120 days from the date of opening of quotations.
- 6) Contract period:** The accepted rate shall remain valid for six months from the date of supply order. This period may be extended by the E.I.C. for another three months, if required. The supplier shall be bound to supply the material within that extended period of three months at the same rate and same terms & conditions of existing contract.
- 7) Excess supply:** 25% excess of the contract quantity will have to be supplied by the supplier within the twelve months from the date of receipt of supply order or in extended period of three months. If asked for, at the same rate & terms & conditions of existing contract.
- 8) Pricing:** The quoted price shall be inclusive of the all taxes duties & levies and delivery charges etc. But the detailed break up of price shall have to be shown. No 'C' form will be provided. Octroi, if any shall have to be included in the carriage and delivery charges.
- 9) Price escalation:** Escalation shall not be allowed within contractual period except increase in statutory taxes and duties decreases shall be counted accordingly.
- 10) Penalty of default:** In the event of failure to supply the indented quantity within the stipulated time as noted in the body of indent / or any program / or as stated in this quotation document / or as directed by E.I.C. H.M.C. authority reserves that right to purchase that materials from any other source without any reference to the defaulting supplier & the defaulting supplier will be bound to bear the extra cost required from such purchase. If the supplier fails totally to supply the material as per our supply schedule as stated above he may be black listed along with forfeiture of earnest money.
- 11) Payment:** No advance payment shall be made. Payment will be made against delivery of a suitable lot provided that the bill submitted along with satisfactory test certificate. Deduction of IT & ST as per existing

rule shall be made from the bill. Successful tenderer shall have to execute as agreement in proper format without which no payment will be made.

The above mentioned Tender “Yearly requirement of 250 MT or part thereof Poly Aluminium Chloride (PAC) 10% HB as per IS: 15573:2005 at Howrah Water Works Padmapukur.” **"PART-I" will be opened on 12.05.2023 at 1:00 P.M. or later** and if after opening it is found that all details as required to be found in the said cover are not submitted by the tenderer, the corresponding "PART II" may not be opened at all and the tender may be liable for rejection.

After scrutiny and clarification of the various proposals submitted by the tenderer in "PART-I" of the tender, the cover marked "PART- II" of the tenders found to be technically or otherwise acceptable will be opened in the presence of the intending tenderers or their authorized representatives on date & time to be communicated after a technical conference if required.

Any tenderer who shall not strictly adhere to the procedure outlined herein is liable to have his tender summarily rejected.

The tender shall be prepared in indelible ink and legibly written. Over-writing shall not be allowed. Corrections should be scored through under the signature of the Tenderer and written afresh. **No white correction fluid shall be used.**

All rates and prices shall be written in figures as well as in words. In case of any discrepancy between the two, works shall prevail over the figures.

The Tenderer is to sign at all places indicated in the tender documents, and where required the signature is to be duly witnessed. The person signing on behalf of the tenderer must have legal authority to do so, and if subsequently asked for, the tenderer shall have to satisfy the tender inviting authority about the same.

In addition to above, the Tenderer has to sign (or put his initials on tenderer's stamp or seal) on every page of the tender documents including the tender drawings thereof, and including addenda and circular letters (if any) that may have been issued in terms of the provisions of clause B-2.2 hereof.

No alteration shall be allowed in the Tender Documents by the tenderer.

Any comments or statements or qualifications the tenderer might desire to make shall be prepared in a separate documents. The statements or comments shall be brief and properly referenced as to items, clauses and pages of the corresponding documents. It must be however clearly understood that the authority inviting tenders expects the Tender to be based on the provisions of the Tender Documents as issued to tenderers. Any major deviation there from is strongly discouraged and a Tender with such a deviation, and particularly when it involves financial implications of such a nature as to make comparative evaluation of tenders difficult, is likely to be a cause for rejection of the Tender without further reference to the tenderer.

SCHEDULE OF PRICES

The Tenderer shall fill in the rate against individual items both in figures and words and in case of any discrepancy the rate in works shall govern. The rates against different items should be reasonable and commensurate with one another. Any rate which, in the opinion of the authority accepting tenders, is absolutely high or absolutely low in comparison to the quoted rates of other items, may lead to rejection of the Tender. The Authority, may also at its discretion, re-appropriate the rates of different items, the total quoted amount remaining constant.
