[for 2nd Call] **Intending tenderers should produce credentials of a similar nature of completed work of the minimum value of 30% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or, ii) Intending tenderers should produce credentials of 2(two) similar nature of completed work, each of the minimum value of 25% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice; or, iii) Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 75% or more and value of which is not less than the desired value at (i) above; In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e., the tenderer. Technical Specification & Terms & Conditions

Name of Work:- Supply of 24 (Twenty four) M.T or part there of Liquid Chlorine conforming to IS: 646-1986 (2nd Rev. Amdt-1, Reaffirmed 1991), purity of 99.80% at Howrah Water Works, Padmapukur (2nd Call).

- ❖ **Material:** Liquid chlorine to be supplied must conform to the IS: 646-1986, (2nd Revision)
- ❖ **Size of Cylinder:** The size of cylinder should be 2035 mm x 750 mm dia. approx but not more than 2100 mm x 775 mm dia. each cylinder should contain 900 kg. approx liquid chlorine.
- ❖ **Supply Schedule:** 3 to 5 M.T of liquid chlorine to be supplied in each month from the date of supply order subject to availability of storing space. However, supply schedule may be changed as per direction of EIC delivery of liquid chlorine filled cylinders shall have to be made within 3 (three) days (maximum) from the date of intimation.
- ❖ **Place of delivery:** The materials to be delivered at Padmapukur Water Works, Howrah, 9, Andul Road, Howrah-711 109 as directed by EIC or his authorized representative.
- ❖ **Testing:** Testing of liquid chlorine gas may be done as per direction of EIC as and when required from Govt./Semi Govt./Departmental/ approved laboratory. Necessary fees for sample testing as claimed by the Govt./Semi Govt. laboratory etc. is to be deposited by the supplier before testing. If any lot found not as per said material specification after testing that may be rejected at the direction of Engineering Adviser/ E.I.C
- ❖ **Validity of offer for acceptance:** The offer shall remain valid for acceptance for 120 days from the date opening of quotations.
- ❖ **Contract Period:** The accepted rate shall remain valid for 1 (one) year from the date of supply order. This period may be extended by the EIC for another three months, if required. The supplier shall be bound to supply the material within that extended period of three months at the same rate and same terms & conditions of existing contract.
- ❖ **Excess Supply:** 25 % excess of the contract quantity will have to be supplied by the supplier within the twelve months from the date of receipt of supply order or in extended period of three months. If asked for at the same rate & terms & conditions of existing contract.
- ❖ **Pricing:** The quoted price shall be inclusive of the all taxes duties & levis and delivery charges etc. But the detailed break up of price shall have to be shown. Since 'C' from the purpose of S.T shall not be given the suppliers should take it into account while quoting their rates. Ontario, if any shall have to be included in the carriage and delivery charges.
- ❖ **Price escalation:** Escalation shall not be allowed within contractual period except increase in statutory taxes and duties decreases shall be counted accordingly.
- ❖ **Penalty of default:** In the event of failure to supply the indented quantity within the stipulated time as noted in the body of indent / or any programme /or as stated in this quotation document/ or as directed by EIC, HMC

authority reserves that right to purchase that materials from any other source without any reference to the defaulting supplier & the defaulting supplier will be bound to bear the extra cost required from such purchase. If the supplier fails totally to supply the material as per our supply schedule as stated above he may be black listed along with forfeiture of earnest money.

- ❖ **Payment:** No advance payment shall be made, 100 % payment will be made against delivery of a suitable lot provided that the bill submitted along with satisfactory test certificate. Deduction of IT & ST as per existing an agreement in proper form as directed by Engineering Advisor, HMC in triplicate copies of Tender copies of Tender documents without which no payment would be made.
- ❖ **Rental Charges:** There must be at least 40 (forty) days rent free period for the supply of liquid chlorine in big drums/cylinders. No rental charges is payable on empty cylinders which are not collected by suppliers within rent free period in spite of being requested by EIC or any of his representatives.
- ❖ **Acceptance/ rejection of offer:** The quotationer must again sign at the bottom of each page of the quotation document. No quotation will be deemed to be fit for consideration unless the quotation documents are completely filled in. All information that may be asked from the quotationer must be unequivocally furnished. Any quotation which is incomplete or does not complete with the prescribed conditions or stipulates any condition other than these laid down herein or in any other part of this quotation document may be liable to rejection at the time of opening or during scrutiny.

SPECIAL TERMS AND CONDITONS

- 1) **Bidder must possess valid explosive license from appropriate Government authority for dealing in Liquid Chlorine.**
- 2) **PACKING AND MARKING**

Packing – Chlorine shall be supplied in liquefied condition in suitable cylinders or other containers whose capacity shall be subject to agreement between the purchaser and the supplier as mentioned. The cylinders shall comply with the requirements for cylinders for liquid gases given in the Gas Cylinder Rules, 1981, of the Government of India, with such modifications as may be ordered from time to time by the Chief Inspector of Explosives, Government of India, or any other duly requirements set out by the above mentioned authority and be approved by such authority. The packing, marking and labeling of cylinders shall be in accordance with the requirements of cylinders for liquid gases given in the Gas Cylinder Rules, 1981, with such modifications as may be ordered from time to time by the Chief Inspector of Explosives, Government of India, or any other duly constituted authority. Other containers shall also be marked and labeled in accordance with the Instructions issued from time to time by the above mentioned authority. Chlorine cylinders shall be painted with a coat of golden yellow IS Colour No. 356 (see IS: 5-1978+) paint. The size of the cylinder should be approx. 2025-2100MMX675-750MM and weighing approx. 850-950kg. Suppliers must ensure that the cylinders are in good condition and tested by appropriate/accredited agencies and that all parts and accessories are functioning properly. Suppliers will have to produce the copies of test certificate of the toners, if asked for. Weight of the material in cylinders must be certified by the manufacturer.
- 3) Each consignment shall be accompanied by four copies of challan.
- 4) Parties will have to give an undertaking that in case of any leakage/ malfunctioning of cylinders, they will attend the problem immediately and if necessary, will replace the cylinder(s) without any delay. No additional charges will be paid for such cases. In case of non-compliance penal action will be imposed as deemed fit by the authority. HMC will not be liable for any hazardous incident occurring due to such leakage.
- 5) All empty cylinders from the deliver sites will have to lifted immediately after due information from HMC authority. In case of non-compliance penal action will be imposed as deemed fit by the authority.
- 6) Quoted price shall include statutory payments (like GST or any other Govt. taxes as applicable). escalation of Price on any ground and consequent cost overrun shall not be entertained under any circumstances. Rates should be quoted accordingly. Successful Bidders may have to submit the price breakup analysis such that the arrival of quoted/ offered rate (price) can be clearly understood.
